



## Communicable Disease Plan

As of July 7, 2021, our COVID-19 Safety Plan has been transitioned into a Communicable Disease Plan for all in-person training sessions in accordance with BC Government's Guidelines for Step 3 of the BC Restart plan. Stardust's Plan is also in line with the communicable disease prevention guidance from WorkSafeBC.

As of August 25, 2021, and in accordance with BC Government's Orders, masks are required in all public indoor settings for all people born in 2009 or earlier (12+). This includes Stardust Solar office and classrooms as these areas are used to facilitate service to the public (solar students).

There are exemptions for:

- People with health conditions or with physical, cognitive, or mental impairments who cannot wear one
- People who cannot remove a mask on their own
- Children under the age of 12
- People who need to remove their masks to communicate due to another person's hearing impairment

A face shield is not a substitute for a mask as it has an opening below the mouth.

In accordance with Ministry of Health recommendations, Stardust Solar will ensure that fundamental measures of communicable disease prevention are in place at this location, including appropriate handwashing and personal hygiene practices, appropriate ventilation, and staying home when sick:

- Hand Sanitizer readily available throughout our facilities. (See SDS)
- Face Masks available for every customer and attendee. (\*Per guidelines as above)
- Social Distancing seating with a minimum spacing of 6 feet between seats.
- Surface Disinfection daily, before and after every training session. (See SDS)
- Posted Signage throughout our facilities to maintain clarity of safe practices.
- No-Touch Policy from all caterers and vendors.

Students shall complete the **COVID-19 Self-Disclaimer** of Recent Travel, and Self-Disclaimer of Symptoms or contact with anyone experiencing Symptoms.

By order of the Provincial Health Officer (PHO), proof of vaccination will be required to access some events, services, and businesses. In order to enter Stardust's office or classroom, Starting September 13, you must have proof of at least one dose of a COVID-19 vaccine.

By October 24, you must be fully vaccinated. The requirement applies to all people born in 2009 or earlier (12+) and covers events, businesses, and services where you will be asked to see your proof of vaccination and valid government ID. You'll be able to show your proof of



vaccination easily using the B.C. vaccine card website. **The secure website will be available for September 13** and will provide confidential access to your proof of vaccination.

The requirement is in place until January 31, 2022, subject to extension as per the BC Government's update on August 23, 2021.

**Enforcement:** During a public health emergency under the Public Health Act, the PHO can make orders as needed. Stardust must follow the orders. Some orders can be enforced by police or other compliance and enforcement officials. People who don't follow these orders could be fined.
